- 1) Further to the notice dated 22-11-2022, 12-01-2023, 10-02-2023, 10-03-2023, 24-04-2023, 05-06-2023, 19-07-2023, 10-08-2023, 19-09-2023, 28-10-2023, 28-11-2023, 28-12-2023, 29-01-2024, 22-02-2024 & 15-03-2024, 5 (Five) candidates bearing the roll number given below has been provisionally shortlisted for Document Verification (DV) and Medical Examination down from the merit list in order to fill the shortfall in empanelment of candidates for the posts in Pay Level 5, due to absent, Unfit in prescribed Medical Standard etc.
- 2) Candidates is advised to report to Railway Recruitment Board, No. 18, Millers Road (Behind Cantonment Railway Station), Bengaluru - 560046, as per scheduled date and time mentioned below.
- 3) SMS/E-mail alerts are being sent to candidates' registered mobile / email ID for downloading their e-call letter from RRB's website.
- 4) The candidates called for DV should produce all the original documents along with two sets of photo-copies in A4 size as detailed in the CEN and e call letter issued for Document Verification.
- 5) Those candidates who are called for Document Verification may note that after completion of DV, they will be sent for medical examination at the nominated Railway Hospital located in the jurisdiction of concerned RRB on the next day of the DV. The candidates are required to come prepared to stay for more than four days for DV/Medical examination at their own cost. Candidates have to pay the prescribed medical fee of Rs 24/- only. There are no other charges to be paid to the Hospitals/Health Unit for the medical examination. In rare cases, where the investigation like CT Scan, Ultra Sound, tests to rule out refractive eye surgery etc., have to be carried out for which necessary facility is not available in the Railway Hospital/Health Unit, then for such investigation, candidates may have to make the requisite payment to the concerned laboratory/hospital.
- 6) The candidature of all the shortlisted candidates is purely provisional and is liable to be cancelled at any stage of recruitment or thereafter, in case of any inconsistency/ deficiency/ discrepancy detected in the information furnished by them in their online application or any malpractice on their part coming to the notice at any stage of the recruitment process or thereafter.
- 7) It is to be noted that merely shortlisting or calling a candidate for Document Verification/Medical examination does not entitle him/her in any way to an appointment in the Railways.
- 8) While every care has been taken in preparing the result, RRB reserves the right to rectify any inadvertent error or typographical/printing mistake etc. RRB regrets the inability to entertain any correspondence on this account from the candidates.

Candidates are advised to upload colour scanned copy of their passport size photograph and signature in RRB Document Verification portal <https://oirms-ir.gov.in/rbdrv/> duly following the instructions mentioned therein. This portal will be active for uploading from 10 days prior to date of DV and closes on the date of DV.
2. Candidates wearing spectacles are advised to carry the same for medical examination.
3. Candidates are advised to strictly adhere to COVID norms as per Advisory issued by Government of Karnataka.
4. Block date for verification of original documents for candidates absent on Regular DV date: 17-05-2024.
Candidates appearing for document verification on Block Date should produce documentary evidence that the candidate had to appear in a University/Government examination or due to sickness on the date of Regular DV. No other reason for absence will be considered.
5. Failure to report for document verification on Regular or Block dates will tantamount to rejection of candidature and no correspondence in this context will be entertained.
